## 2. Job Profile/Responsibilities

The candidate should assist in the following tasks:

- (a) Supports the effective daily operation of the SAP system by using technical and functional knowledge and understanding of the Institute's business processes.
- (b) Acts as an interface between end users/departments/admin units and SAP Functional Consultants, as well as an interface between the Business Process Owners (BPOs)/Key Business Users (KBUs) and the respective Wipro Functional Consultants related to the system issues, service requests, and change requests for new requirements.
- (c) Regularly coordinates and collaborated with SAP functional consultants of the respective SAP functional modules to discuss and assess:
  - (i) New requirements and related Business Requirement Documents (BRDs) and Change Requests (CRs)
  - (ii) Changes in business processes
  - (iii) System performance issues
  - (iv) Implementation bugs
  - (v) SAP best practices
  - (vi) Review the user Complaints and tickets
- (d) Participates in the System and User Acceptance Testing of the new developments, enhancements, and bug fixes in the respective SAP application modules.
- (e) Trains and guides the SAP end users with the SAP functions, processes, workflows, and User Interfaces.

(f) Develops and maintains documentation and may provide training related to the SAP Implementation, custom queries, reports, or other technology resources.

## 3. Skills

- (a) Strong technical aptitude is required.
- (b) Over a period of six months, must be able to work independently, manage multiple concurrent tasks and work with people with differing technical knowledge levels.
- (c) Excellent oral presentation and written communication skills are required.
- (d) Must be detail oriented.
- (e) Experience using word processing, spreadsheet, and other financial software is preferred.
- (f) Knowledge of basic accounting principles and financial reporting is preferred.
- (g) Competency in the use of query and report tools is preferred.
- (h) Good knowledge of database technologies like MS SQL or any other RDBMS is preferred.
- (i) Good programming skills will be preferred.

## 4. Duration

Engagement is purely temporary on a contract basis, initially for a period of **one year** and renewable annually up to a maximum duration of **five years**, based on the satisfactory performance and requirements of the Institute. Contract tenure will commence from the date of joining. An increment up to a maximum of 6% may be admissible in case of an extension of the contract, based on the performance of the candidate and the recommendation of the Chair.

5. **Selection Procedure:** Academic performance of the candidate (I.e., marks obtained), will be considered for shortlisting. Shortlisted candidates will be called for an online/in-person Interview.
