2. Job Profile/Responsibilities

- (a) A psychiatric social worker helps people who struggle with mental health problems and cope with them.
- (b) PSW provides counseling services to clients to help them to cope with psychological problems.
- (c) PSW meet with other members of the mental health team (psychiatrists, nurse practitioners, etc.) to discuss Client care.
- (d) Psychiatric social workers should also offer individual and group therapy sessions to patients.
- (e) PSW should conduct regular awareness training for supporting staff and the Institute community to make them aware of mental health and mental hygiene.
- (f) Maintain case records and prepare reports of each patient.
- (g) Wellness coordinators are required to be available on campus on all working days and on Saturdays for the campus Institute community. They are also available to attend to an emergency at any time.
- (h) All other works assigned from time to time.
- (i) Works related to the SAP implementation, custom queries, reports, or other technology resources.

3. Duration

Engagement is purely temporary on a contract basis, initially for a period of **one year** and renewable annually up to a maximum duration of **five years**, based on the satisfactory performance and discretion of authorities of the Institute.
