2. Job Description:

The primary responsibility of the system administrator is to support procurement, maintenance, accounting, demonstration, use, and documentation of (the working of) all computing equipment, software tools, and computing-related consumables in the Teaching Laboratories, Research Laboratories, office, and other areas of CPDM, and supporting websites, experiments, demonstrations and projects that involve use of computing facilities. The responsibilities include the following:

- a) General computer system administration (of Servers and clients)
- b) Office network management
- c) Automated backups of databases, applications, and system configurations
- d) Tuning scheduled jobs on the servers for optimal performance and consistency, etc.

3. Duration:

Engagement is purely temporary on a contract basis, initially for a period of one year and renewable annually up to a maximum duration of five years, based on the satisfactory performance and requirements of the Institute. Contract tenure will commence from the date of joining. An increment up to a maximum of 10% is admissible in case of extension of the contract, based on satisfactory performance and availability of funds
